- 2) Rules and Regulations made by the Govt. and the University, as amended from time to time, will be binding on the College.
- 3) The college should obtain the permission for admitting the students from the Admission Regulating Authority, Mumbai.
- 4) The college should obtain approval of fee schedule for the admission of the students from the Fee Regulating Authority, Mumbai.
- 5) The college should obtain approval / recognition of teachers from Maharashtra University of Health Sciences, Nashik.
- 6) This revised First Time Affiliation to start B.A.M.S. (UG) course with 100 intake capacity is valid for Academic Year 2022-23 only.
- 7) The next batch of students shall not be admitted unless 'Continuation of Affiliation' is obtained by college/Institute from the MUHS.
- 8) The college shall not admit the students for the Academic Year 2022-23 after the cut-off date prescribed by the CCIM / (NCISM), New Delhi.
- 9) The students shall be admitted only after obtaining the permission of concern council / Commission & competent Authority of the State Govt.
- 10) Bank Guarantee should be submitted to the MUHS within a period of 1 month from the date of issuance of this letter to the University.
